Emphasizing the importance of meticulous data collection, analysis, and documentation, Dean of Academics M. N. Jha highlighted their role in securing a favorable assessment. Supporting this approach, IQAC Coordinator Dr. Sandeep Kumar advocated for the establishment of a dedicated task force to oversee data collection and verification processes.

The resulting Action Taken Report (ATR) is then submitted to the department DAC for approval before implementation.

- **Data Insights:** Dr. Ajay Kumar presented key metrics on ongoing initiatives, showcasing successes and areas for improvement.


This reinforced the institution's commitment to continuous quality enhancement through collaboration

2. **Status Enquiries:**
 - Members inquired about the current status of various reports and assessments:
 - **IIQA:** IIQA submitted & approved on 18.07.2024
 - **NIRF (National Institutional Ranking Framework):** Discussion on the data compilation and submission process, ensuring alignment with ranking criteria.
 - **AISHE (All India Survey on Higher Education):** Updates on the data collection and submission status for the survey, focusing on compliance with reporting requirements.
 - **SSR (Self Study Report):** Review of the preparation progress for the NAAC Self Study Report, addressing any gaps and ensuring thorough documentation.

These discussions and updates emphasized the institution's proactive approach in preparing and submitting necessary documentation for accreditation and assessment activities, ensuring compliance and readiness for evaluation.
