2. Grievances:

Grievance 1: Need for additional Sanitary Napkin Vending Machine

Complainant: Harshita Setia, BCA 3rd Year

Details: SGRC Student Representative, Ms. Harshita Setia, raised a concern about the insufficient number of Sanitary Napkin Vending Machines on campus. She requested the installation of additional machines in key locations to improve accessibility for girl students. This initiative aims to enhance convenience and promote hygiene on campus.

Action Taken: The committee has noted the grievance and discussed the feasibility of installing additional vending machines with Ms. Preeti Batra, PRO, TIAS. The procurement process has been initiated, and the new machine is expected to be installed within the next two weeks. The team has been tasked with identifying the best locations for these machines to ensure maximum accessibility.

Grievance 2: Students' request for additional seminars

Complainant: Sampan Bhatia, BBA 3rd Year

Details: A student of BBA has expressed the need for more seminars to enhance their academic and professional development. Students feel that additional seminars on diverse topics would provide valuable learning opportunities and complement their coursework.

Action Taken: The committee acknowledged the students' request and discussed the feasibility of organizing additional seminars with Head of Department of Management Sciences. Plans are underway to schedule more seminars for the upcoming semester, with a focus on both academic subjects and extracurricular topics. Faculty members and external experts will be invited to lead these seminars, and information will be shared with students.

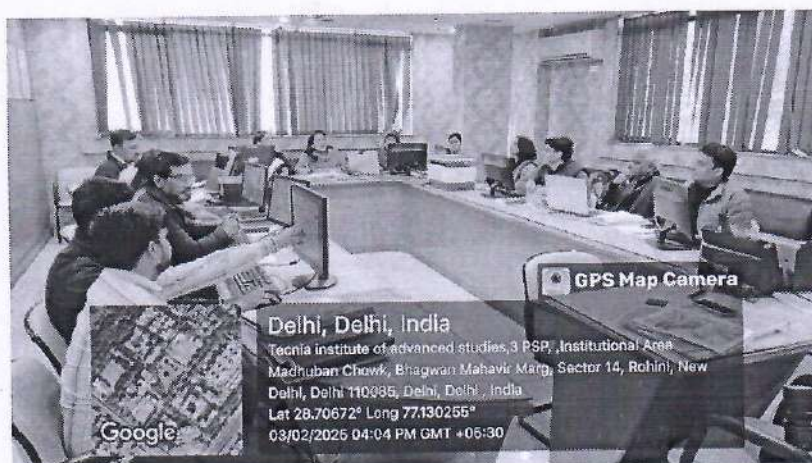
