TIAS and Hotel Eigerblick agree to hold in confidence all information/data designated by the parties as being confidential which is obtained from either of the parties or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other party.
- ii. The above confidential clause under this MOU excludes the information/data possessed by either party before entering into this MoU or independently developed and/or information already available through public domain.

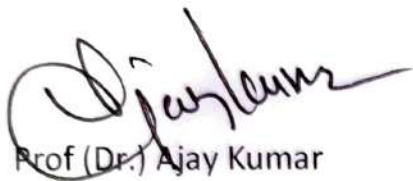
5. Duration of MOU
