NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of Second Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co- operation between the two would be of major benefit to the student & Faculty community to enhance their skills and knowledge.
- 2.2 Curriculum Design: First Party will give valuable inputs to the Second Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

- 2.3 Research and Development: Both Parties have agreed to carry out the joint research activities in the fields of Organization.

- 2.8. Research Publications: Both parties have agreed to publish research papers of both in the Journals/ Proceeding vice versa.
- 2.9 Short course of 2 Credit in IKS is Mandatory according NEP-2020 & (Chargeable Fees)
- 2.10 There is no financial commitment on the part of the both party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 4 VALIDITY

4.1 This Agreement will be valid for Two years until it is expressly terminated by either Party on mutually agreed terms. Any act on the part of Tradepreneur Global Academic Platform, the first Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

4.2 Both Parties may terminate this MOU upon two months' notice in writing. In the event of Termination, both parties have to discharge their obligations.

4.3 Its mandatory to make functional MoU, otherwise it will null and void.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES
