ORDER

In exercise of the powers conferred by Section 17 read with Clause (g) of Section 3, and Section 13 of The Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 08 of 2007), the Government of National Capital Territory of Delhi, for smooth affiliation, admission and other regulatory processes in respect of self-financing colleges affiliated with Guru Gobind Singh Indraprastha University (GGSIPU), which was appointed as the designated agency under the said Act *vide* order dated the 5th May, 2011, hereby orders following interim measures for immediate implementation:-

- 1. Alignment with Statutory Regulatory Body Prescribed Norms and Acceptance of Statutory Body Approvals Regarding Intake-** In continuation to the Clause 1.1 read with Clause 1.1(iii)(d) of DHE, Govt. of NCT of Delhi, Policy Guidelines dated 12.01.2016 it is further clarified that the approval of the Statutory Regulating Body in respective program/course wherever applicable, specifying the permitted intake shall be duly accepted for issuance of NOC by the Government.
- 2. Applicability of Built-up Area Norms:** Wherever, the norms and guidelines have been prescribed by the Statutory Regulatory Body, the same would be adopted *mutatis mutandis*. In the case of programs not covered by the norms and guidelines of the Statutory Regulatory Body, the provisions of Policy Guidelines dated 12.01.2016, specifically sub-clause (iii)(h) of Clause No. 1.1 shall continue to be considered as the same are considered by Statutory Regulating Bodies in respect of programs covered under their jurisdiction.
- 3. Regarding the admission process, as the resources of the University and its affiliated colleges are going unutilized each year, the existing Policy of Rank-Capping is being discontinued.**
- 4. Physical Admission Counselling by designated agency:** The physical admission counselling held by the designated agency i.e., GGSIPU shall be on a similar pattern as being done by the DTU, NSUT, IGDTUW, IIIT-D, where the merit list of candidates for conduct of physical offline counselling is only prepared of the candidates who report for admission counselling on that day of physical offline counselling and thereafter the vacant seats available are allotted on basis of the merit of candidates present on that day.
